AGREEMENT FOR EXCHANGE/STUDY ABROAD

BETWEEN

MORGAN STATE UNIVERSITY IN BALTIMORE, MARYLAND, USA

AND

MES COLLEGE OF ENGINEERING, KUTTIPPURAM & MES COLLEGE OF

ARCHITECTURE, KOZHIKODE, KERALA, INDIA

Morgan State University, an agency and instrumentality of the State of Maryland, located at 1700 E. Cold Spring Lane, Baltimore, Maryland (USA), hereinafter referred to as "MSU" and MES College of Engineering, MESCE, Kuttippuram, and MES College of Architecture, MESCOA, Kozhikode, Kerala, India, hereinafter referred to as "MESCE" & MESCOA, collectively "MES", have developed this Memorandum of Understanding (MOU) to establish the following agreement:

ARTICLE I: OBJECTIVE OF THE AGREEMENT

The purpose of this Agreement is to establish a mutually-beneficial education and research relationship in all fields and disciplines offered at MSU and the institutions run by MES. Cooperation between MSU and MES will be undertaken from the perspective of promoting academic and cultural ties. The Agreement establishes between MSU and MES a formal understanding of the scope of operations, and for the following activities.

ARTICLE II: SCOPE OF AGREEMENT

This Agreement is subject to the availability of funds of either party. Activities covered by this Agreement include:

- Section 1. The exchange of students from each party for traditional student exchange programs;
- Section 2. The exchange of faculty members for teaching, research, or both; or the hosting of visiting faculty from the other party;
- Section 3. The organization of joint seminars and conferences;
- Section 4. The exchange of academic program materials;
- Section 5. The development of joint research and publications; and
- Section 6. Study Abroad of students between the Parties; however, the modalities for study of students of MSU in India under this agreement will have to be worked out on an individual basis.

ARTICLE III: GENERAL PROGRAM REQUIREMENTS

Section 1. In this Agreement, unless the context implies otherwise:

- a) "Exchange" shall mean a one-for-one exchange of students from each Party;
- b) "Exchange students" shall mean students participating in the exchange implemented herein;

- c) "Home institution" shall mean the Party the student intends to graduate from;
- d) "Host institution" shall mean the Party that has agreed to receive the exchange students from the home institution;
- e) "Study Abroad Students" shall mean degree seeking or non-degree seeking students participating in a two week to two year program at the Host Institution;
- f) "Visiting Students" shall mean degree-seeking students with comparable transferring credits participating in a one semester to two-year program at the Host Institution.

Section 2. Tuition and fees:

- a) Students attending either Party as exchange students, study abroad or visiting students shall register and pay the normal tuition fees to their Home Institution when attending the Host Institution. Students attending either Party as degree seeking students shall pay tuition as determined by the Host Institution.
- b) Exchange programs established under this Agreement shall operate on a reciprocal, no-cost basis. Tuition normally charged to students by their Home Institution shall be paid by students directly to their Home Institution. The Parties shall ensure that no additional tuition costs are charged or collected for Exchange students. Fees for campus services may be charged to the visiting student.

Section 3. Funding Resources:

Each Party affirms that its Exchange students will have the necessary personal funding resources to fully meet their financial obligations as students. Each Party affirms that its participating students will have health and accident insurance coverage to include costs of emergency evacuation and repatriation.

Section 4. Housing and travel:

The Host Institution will facilitate the arrangement of lodging for Exchange students and faculty, but all expenses incurred for travel, lodging, and other incidental costs associated with the program (laboratory fees, special activity fees, etc.) shall be borne by each individual participant. Arrangements for other Party-to-Party payments may be negotiated as necessary and must be agreed to in writing by both Parties.

Section 5. Student conduct and academic policy:

While at the Host Institution, Exchange students are subject to the student conduct and academic policies of the Host Institution for matters specifically related to their program. All Exchange students must adhere to all course load requirements for student visas under federal and state laws. Both Parties retain sole discretion to dismiss a student from the program at any time for failure to maintain appropriate standards of conduct according to the Host Institution's policies and standards. Students so dismissed will be deregistered from all classes, all tuition and fees will be forfeited in accordance with the Host Institution's policy, and the student so dismissed will be expelled from student housing and escorted to the airport by a designated official. Neither Party is

responsible for any fees due to the airline, which must be paid by the student or will be charged to the Home Institution if the student does not have the necessary funds. Notice of such dismissal shall be sent to the Dean of Students, or equivalent office, at the student's Home Institution.

Section 6.

The Parties will consult and establish the number of students to be exchanged as full-time degree seeking, non-degree seeking students under the provisions of this Agreement by December 1 of each year.

Section 7.

The Parties retain at all times the ultimate authority over all admission and subsequent academic decisions respective to each. All Exchange students from MES must have the appropriate level of "Testing English as a Foreign Language" (TOEFL) or alternatives to include "International English Language Testing System" (IELTS) or "Michigan English Language Assessment Battery" (MELAB) and other test scores required for their respective degree program. If it is determined that a student does not have a sufficient level of English proficiency, he/she will be required to undertake appropriate "English as a Second Language" (ESL) education prior to formal admission to the program. Exemptions may apply for students primarily educated in English speaking countries or territories.

ARTICLE IV: EXCHANGE OF FACULTY MEMBER AND HOSTING OF VISITING FACULTY

The process for establishing an exchange of faculty members shall be as follows:

- a) Interested faculty members submit teaching and/or research proposals to their own institution's academic officers for review and approvals of concept.
- b) Proposals must include explanation of the source and method of compensating and funding the expenses of visiting faculty members.
- c) Approved proposals and the proposing faculty member's credentials are sent to their counterpart faculty member(s) and academic officers for review and approval by the Host institution.
- d) If there is mutual interest, the academic officers of the Host Institution shall contact the proposing faculty member(s) and their academic officials, inviting a fuller outline of the terms and conditions under which the visit would take place.
- e) The purpose of any such visit must be teaching or cooperative research.

ARTICLE V: TERM AND TERMINATION

This Agreement shall be effective upon its mutual signing and remain in effect for a period of five years, and may be amended or extended upon written agreement by the Parties. This Agreement may be cancelled by either Party in writing with 90 calendar days' notice. In the event that the Agreement is not renewed or is terminated in any other way, any related activities in progress shall continue until the current semester in which the termination takes place is completed.

ARTICLE VI: REPRESENTATIONS AND WARRANTIES

Section 1.

MSU represents and warrants that it is an agency and instrumentality of the State of Maryland, acting in its higher education capacity, and has the legal capacity to enter into this Agreement.

Section 2.

MES represents and warrants that it (1) is an educational entity in good standing in the country of India and has the legal authority to enter into this Agreement; and (2) has obtained all necessary approvals and rights required by applicable laws, rules and regulations necessary to enter into, and perform under, this Agreement.

ARTICLE VII: MISCELLANEOUS

Section 1. No Agency:

Nothing herein shall be construed to create an agency relationship between the Parties, or any employment relationships between the Parties for any faculty or staff member provided under the exchange program. The Parties are independent contractors and no legal relationship is intended by this Agreement.

Section 2. Compliance with laws:

The Parties will comply with all applicable laws and regulations in their respective countries in performing their obligations hereunder.

Section 3. Anti-Kickback Enforcement Act of 1986, Public Law 99-634 (41 USCA §§51-58). By agreeing to this binding Agreement, the Parties:

- a) certify that they have not paid kickbacks directly or indirectly to any employee of MSU for the purpose of obtaining this or any other agreement, purchase order or contract from MSU; and
- f) Agree to cooperate fully with any Federal Agency investigating a possible violation of the Act.

Furthermore, both Parties recognize their duties under the Foreign Corrupt Practices Act of 1977 (15 USCA §§78dd-1), which makes it unlawful for certain classes of persons and entities to make payments to foreign government officials to assist in obtaining or retaining business.

Section 4. Utilization of logos and other university propaganda:

Neither the Home nor the Host Institution shall use any identifying marks of the other without the express written permission of the other Party.

Section 5. Equal Opportunity:

Both Parties subscribe to a policy of equal opportunity and shall not discriminate on the basis of age, race, gender, religion, national origin, marital status, sexual orientation, veteran status or physical disability.

Section 6. Authoritative Version:

The English version of this Agreement shall be the authoritative version of the Agreement for all purposes. In the event of a conflict between the English version and any translation of this Agreement, the English version shall control.

Section 7. Severability:

If any section or provision of this Agreement is held illegal, unenforceable or in conflict with any law by a court of competent jurisdiction, such section or provision shall be deemed severed and the validity of the remainder of this Agreement shall not be affected thereby.

Section 8. Whole Agreement and Amendments:

This Agreement contains the entire agreement between the Parties and shall not be modified, amended or supplemented, or any rights herein waived, unless such amendment or modification to this Agreement is (i) in writing; (ii) refers to this Agreement; and (iii) executed by an authorized representative of each Party. This Agreement supersedes any and all previous agreements, whether written or oral, between the Parties.

Section 9. Force Majeure:

Neither Party shall be liable for any delays in the performance of any of its obligations hereunder due to causes beyond its reasonable control, including but not limited to fire, strike, war, riots, acts of any civil or military authority, acts of God, judicial action, unavailability or shortages of labor, materials or equipment, impaction or enrollment restrictions ordered by the [University], or failure or delay in delivery by suppliers or delays in transportation.

Section 10. Governing Law:

This Agreement shall be construed in accordance with and governed by the laws of the State of Maryland. The Parties agree that all actions or proceedings arising in connection with this Agreement shall be tried and litigated exclusively in the state and federal courts located in State of Maryland. The aforementioned choice of venue is intended by the Parties to be mandatory and not permissive in nature, thereby precluding the possibility of litigation between the Parties with respect to or arising out of this Agreement in any jurisdiction other than that specified in this paragraph. Each Party hereby waives any right it may have to assert the doctrine of forum *non conveniens* or similar doctrine or to object to venue or jurisdiction with respect to any proceeding brought in accordance with this paragraph, and stipulates that the state and federal courts located in the State of Maryland shall have *in personam* jurisdiction and venue over each of them for the purpose of litigating any dispute, controversy, or proceeding arising out of or related to this Agreement. Any final judgment rendered against a Party in any action or proceeding shall be conclusive as to the subject of such final judgment and may be enforced in other jurisdictions in any manner provided by law.

Section 11. Cooperative Research

- MSU and MES are encouraged to be engaged in joint research and demonstration projects of mutual interest.
- MSU and MES will enter into a separate written agreement to cover items such as equipment, experimental materials, travel, stipend, and any other relevant resources.

Section 12. Intellectual Property

- In the event that the Parties collaborate in the development of intellectual property including, but not limited to, licenses, patents, and inventions, the ownership rights to the intellectual property shall be defined in writing by a separate agreement to be executed by the appropriate administrative officials at MSU and MES.

Section 13. Notices

All notices under this Agreement must be in writing and sent by prepaid airmail and electronic mail as follows:

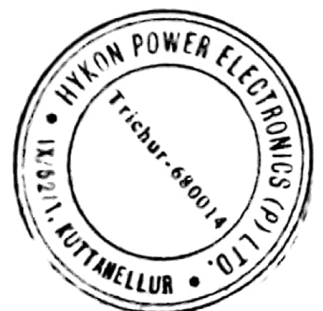



MES College of Engineering, an institution complying to the Eligibility Criteria (Appendix I) and decided by the Screening & Selection Committee of ICTAK (hereinafter called "COLLEGE" which expression shall include its successors and permitted assignees) with its registered office at Thrikkanapuram, Kuttippuram, Malappuram, Kerala 679573

OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is:

- To improve employability skills of the trainees (both Faculty and Students), Assessments and Certifications developed by ICTAK. This will be achieved through resources, regular workshops, training programs, capacity building and faculty development and Career Guidance & Placement support. Under this MOU, the ICTAK will ensure timely completion of training assessment and certification.
- ICTAK will ensure that training, assessment and certification which will be done by ICTAK approved Trainers.

1. SCOPE

Under this MOU, ICTAK provides the following: (Please refer appendix for Course & Fee details)

- One free Faculty Development Program for undergraduate/postgraduate faculty members in the COLLEGE;
- Facilitate the Students Development Program (SDP) using "Paatshala"
- Free entry to Industry - Institute Interaction even at regional level;
- The member institution can participate in the ICT Academy Awards, which will be announced later.
- ICTAK Partner Programme on mutually agreed terms of the Partner Organization.
- Any other programme that are mutually agreed upon.

2. ROLES AND RESPONSIBILITIES

2.1 COLLEGE

- To comply and continuously strive to comply with the Eligibility Criteria to become member of ICTAK program;
- To complete and submit prescribed application form and all relevant documents along with fees and charges for the process of membership and program implementation;
- To ensure participation of Faculty members for respective training programs conducted by ICTAK and to comply with the mutually agreed time schedule;

- d. To ensure participation of students by means of formation of clubs/groups, who are identified and eligible for respective training programs conducted by ICTAK and to comply with the mutually agreed time schedule;
- e. To identify one student among the group to act as student representative/champion (Institutional Student Champion) to assist and co-ordinate with ICTAK in its' activities relating to the effective execution of the training.
- f. To create awareness among Faculty and the students regarding the benefits of the ICTAK program;

- f. To designate a Coordinator (Nodal Officer) who will have responsibility for coordination and implementation of this MOU;

2.3 FACULTY MEMBERS

- a. To commit a minimum of 4 faculty members for its TTT and 20 faculty for any program conducted in the college premises.
- b. To ensure that, those faculty members who have undergone Train- The - Trainer (TTT) Program of ICTAK should be able to train at least 20 students of the same college within a time span of one year from the date of conclusion of TTT.



3. DURATION

 - is independently developed by the receiving party; or
 - Is required to be disclosed by law or court order.
- c. During the term of the MoU and thereafter for a reasonable period, all the parties hereto undertake on behalf of their respective subcontractors/ employees/ representatives/ associates to maintain strict confidentiality and present disclosure thereof, of all the information and data exchanged/ generated pertaining to work/ activity under this MoU for any purpose other than that specified in this MoU.
- d. The member institute can use ICTAK logo and can display in their website or other branding activities during the tenure of the agreement. However, the member institute will cease the right to use ICTAK logo upon expiry/termination of the agreement.

7. NON-EXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, when entering into a similar agreement for Skills Enhancement and Faculty Development Programs, the participants may agree to limit each party's right to collaborate with others on that subject.

12. ARBITRATION



16. ASSIGNMENT

It is understood by the Parties herein this MOU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

17. COSTS OF THE MOU

Each Party shall bear the respective costs of carrying out the obligations under this MOU.

Name of College Shall Provide:

- The required number of computer systems in the lab. and other required infrastructure for the practice
- The Class rooms with LCD projector for the theory classes.
- The Schedule with the classes for this training.
- The supports to ensure that all students who have signed up for the internships, are attending the training programs on time.
- The relevant software installed in the computer systems.
- Disciplinary support for the smooth conduct and timely completion of the entire course.
- Minimum 20 Hours of Training time.

PARTICIPANTS:

- The participants would be the Students of MES College of Engineering Kuttippuram from specified branches from 4th Semester onwards. Initially a minimum 25 numbers of students must be enrolled for any internship programme offered by CADD Centre, the same number can be flexible.

Course Contents:

CADD Centre and its Business Partner in consultation with MES College of Engineering Kuttippuram shall finalize the courses and fees for the skills development program. The same is provided in the ANNEXURE-1. These will be reviewed every year and suitable changes if required, will be incorporated. Time Schedule

Course completion

CADD Centre will not be responsible and accountable for delay in completing the course due to reasons which are beyond the control of CADD Centre and CADD Centre's Business Partner. civil war, rebellion, revolution, insurrection, military or usurped power or confiscation, terrorist activities, nationalization, government sanction, blockage, embargo, labor dispute, strike, lockout or interruption or failure of electricity or telephone service, failure and non-availability of Computer Systems, non-availability of Classrooms), law and order problems, students unexpected strike/boycott, unscheduled changes in college curriculum and other unforeseen circumstances.

- Courses for individual software will be completed as mentioned in ANNEXURE-1.
